The Ministry of Financial Services, Economic Development and Digital Transformation is seeking the services of a competent Catering Service to provide meal services at the temporary Detention Centre located at Hotel Castle Maria for a period of one year.

The proposed service is to ensure compliance in ensuring all meals are prepared and delivered within the time stipulated for meals of persons held in the detention center by the Immigration Department.

Tenderers are required to furnish a completed Form of Tender. This form must be completed without alteration to its wording or format, and no substitutes shall be accepted except for the one provided; Any other materials required to be completed and submitted in accordance with the Instructions to Tenderers embodied in these Tender Documents. The Forms, provided in these Tender Document shall be used without exception.

Failure on the part of tenderers to enclose the supporting documentation indicated above with each respective tender will render the tender non-responsive on the date of the opening of tenders.

Bid documents will be available from **Monday, 15th September, 2025**, on weekdays between 9:00 am to 4:00 pm. Interested tenderers should submit **one (1) original** and **three (3) copies** plus **one (1) flash drive containing the tenderer's documents**.
