The Government of the Virgin Islands invites tenders for the supply and delivery of Ppetrol and diesel for Royal Virgin Islands Police.

The petrol distribution is specifically for the Road Town Station and Virgin Islands Law Enforcement Marine Base locations on Tortola, British Virgin Islands as specified in the attached Appendices.

The successful firm will be expected to deliver the products in accordance with the term and conditions set out in the request for quotations. Provide proactive maintenance of all fuel tank(s) and fuel pump(s), and promptly replace such equipment as necessary to ensure uninterrupted continuity of fuel supply;

Other duties include to plan and execute all maintenance activities in a manner that avoids any operational downtime for the Purchaser. Replace, in advance of failure, any fuel tank(s) or pump(s) that are approaching end-of-life, exhibiting performance degradation, or presenting a risk of failure, among other duties.

Bid documents will be available from between the hours of 9:00 am to 4:00 pm, Monday to Friday. Bidding documents will be sent to bidders electronically upon request to procurement@gov.vg with the subject title "Supply and Delivery of Petrol and Diesel for Royal Virgin Islands Police".

SCOPE OF SERVICES

To provide for the delivery of petrol and diesel to the Government of the Virgin Islands for use by the Royal Virgin Islands Police Force specifically at the Road Town Station and the Virgin Islands Law Enforcement Marine Base. The successful firm will be expected to:

- deliver the products in accordance with the terms and conditions set out in the RFP;
- Provide proactive maintenance of all fuel tanks and fuel pumps and promptly replace such equipment as necessary to ensure uninterrupted continuity of fuel supply;
- Plan and execute all maintenance activities in a manner that avoids any operational downtime for the Purchaser;
- Replace, in advance of failure, any fuel tank(s) or pump(s) that are operating inefficiently, exhibiting performance degradation, or presenting a risk of failure;
- Immediately implement appropriate alternative arrangements to supply the goods in the event of any failure, malfunction, or reduced flow rate of any fuel tank(s) or fuel pump(s);
- Ensure that any alternative arrangements implemented pursuant to Clause 6.1.5 maintain the supply of

Goods in accordance with the agreed specifications and quality requirements, without interruption to the Purchaser's operations.
