Together, these responsibilities help strengthen democratic governance and ensure that Parliament remains responsive to the needs of the Territory.

During the period April to June 2024, Members considered a broad range of parliamentary business that reflected the House's continued commitment to:

Good governance and accountability.
Justice and fairness.
Consumer protection and safety.
Efficient public services.
Constitutional development.
Community wellbeing.

Bills Considered by the House

Consumer Protection (Amendment) Bill, 2024
This Bill aims to strengthen consumer protection and ensure fair trading practices across the Territory.

Elections (Amendment) Bill, 2024
This Bill seeks to modernise electoral laws and improve the integrity of the electoral process.

Resolutions Approved
The House also considered and approved several resolutions that supported the work of Parliament and the wider development of the Territory, including:

Approval of the Constitutional Negotiating Committee, advancing the Territory's constitutional reform process and supporting continued dialogue on the future constitutional relationship of the Virgin Islands.

Appointment of the Special Select Committee on the Elections (Amendment) Bill, 2024, demonstrating Parliament's commitment to detailed scrutiny of significant electoral reform proposals and encouraging public participation in the legislative process.

Resolutions are an important part of a parliamentary business, enabling the House to establish committees, express opinions and authorise actions that support good governance and effective administration.

COMMITTEE BUSINESS

Committees are an integral part of the work of the House of Assembly. While much of Parliament's work is seen during sittings of the House, committees provide an opportunity for Members to examine matters in greater detail and give focused attention to issues that may require further consideration.

Through committees, Members can review information, hear from public officers, organisations and other stakeholders, and consider different perspectives before reporting their findings and recommendations to the House. This helps to strengthen oversight, accountability and informed decision-making.

Committees can also provide an important connection between Parliament and the public by creating opportunities, where appropriate, for persons and organisations to contribute to matters being considered.

Parliament Beyond Legislation

The work of the House extends well beyond considering Bills. Parliament provides a forum where issues of national importance are debated, Government actions are scrutinised, and decisions are taken that influence the future direction of the Virgin Islands.

Whether considering proposed legislation, approving resolutions, establishing committees or debating matters of public interest, Members remain committed to serving the people with integrity, transparency and accountability.
