# **CABINET DECISIONS**

29<sup>th</sup> October 2025

# Cabinet Meeting - 29th October, 2025

His Excellency, the Governor Mr. Daniel Pruce, chaired the meeting held on 29<sup>th</sup> October, 2025.

All Members were present, with the exception of the Minister for Education, Youth Affairs and Sports, and the Attorney General, who were overseas on official duty travel.

Solicitor General Mrs. Jo-Ann Williams-Roberts attended as Acting Attorney General.

#### Cabinet:

- 1. Decided that the following persons be appointed as members of the Crown Lands Advisory Board:
  - a. in accordance with Section 6(1)(c) of the Virgin Islands Crown Lands Management Act, 2024:
    - i. Dirk L. Walters for a period three (3) years, as nominated by the Premier;
    - ii. Archibald Christian for a period three (3) years, as nominated by the Leader of the Opposition;
  - b. in accordance with Section 6(1)(c)(i) of the Virgin Islands Crown Lands Management Act, 2024:
    - i. Marvin Flax Jr. for a period three (3) years, as the representative of Tortola;
    - ii. Coy Levons for a period two (2) years, as the representative of Anegada;
    - iii. LilyMae Durante for a period two (2) years, as the representative of Salt Island; and
    - iv. Steve Lennard for a period three (3) years, as the representative of Virgin Gorda;

- c. in accordance with Section 6(1)(c)(ii) of the Virgin Islands Crown Lands Management Act, 2024:
  - Dylan Penn for a period three (3) years, as the representative for Environment and Planning;
- d. pursuant to section 6(2) of the Virgin Islands Crown Lands Management Act, 2024:
  - i. Adrian A. James for a period three (3) years, as the representative from the field of architecture and as a youth; noted
- e. that the members of the Board would be paid the following stipends outlined below:
  - i. Chairman one thousand dollars (\$1,000.00) per month, by attendance;
  - ii. Deputy Chairman eight hundred dollars (\$800.00) per month, by attendance; and
  - iii. Members five hundred dollars (\$500.00) per month, by attendance; and
- f. that the ex officio members will not be remunerated.
- Approved application for a new crown lease to be issued to Nanny Cay Resort and Marina Limited and an application for permission to use the seabed for installations and updates and a 200 ton haul out facility at Nanny Cay - Nanny Cay Resort & Marina Limited.
