VOTER REGISTRATION AND TRANSFER

12438 The Office of the Supervisor of Elections is notifying the public that persons who are eligible to register to vote and wish to be included on the 2026 preliminary list, that the deadline for registration is **Friday, 28th August, 2026**.

To be qualified to register, a person must be a Belonger as per section (2)(2) of the Virgin Islands Constitution Order 2007, 18 years of age or older, and domiciled in the Virgin Islands. Documents to be presented when registering are

either a Virgin Islands Passport with embossed seal, a Belonger Card, or a Belonger Certificate. A Naturalisation Certificate can also be used, provided the certificate is dated before June 15th 2007.

Further, section 17(1) of the Elections Act, Revised Laws of the Virgin Islands, 2013 states that:

A registered voter, who is ordinarily resident in the Virgin Islands and who moves his or her place of residence from within one local electoral district or polling division to another, may have his or her name transferred to the list of voters for the local electoral district or polling division to which he or she has moved, if he or she applies on Form No. 9 and establishes, to the satisfaction of the Supervisor of Elections, proof of residence within the local electoral district or polling division to which he or she has moved.

Persons who have moved their place of residence and wish to transfer are encouraged to apply for a transfer. Documents to support a transfer can be in the form of Cable, Water, Electricity, or Telephone bills, a rent receipt, a lease agreement, or a notarised document stating the new address.

Registration and Transfer forms are available at the Office of the Supervisor of Elections, Road Town Post Office, the District Offices on Anegada and Virgin Gorda, and the Government Office on Jost Van Dyke. 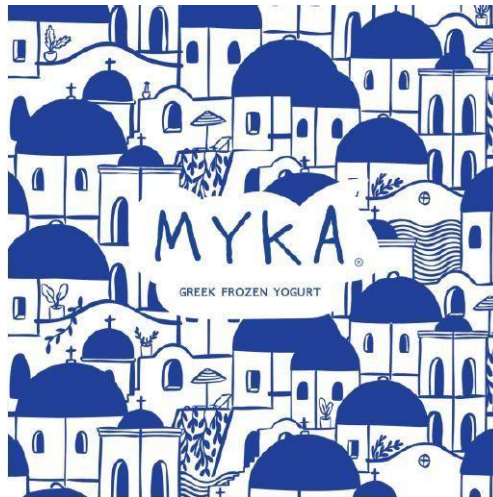

THE CABINET OF THE VIRGIN ISLANDS - POST MEETING STATEMENT

CABINET DECISIONS

17th and 24th June, 2026

10th July, 2026

Cabinet Meeting – 17th June, 2026

His Excellency the Governor Daniel Pruce chaired the meeting held on 17th June, 2026.

All Members were present, with the exception of the Attorney General, who was overseas on official duty. The Solicitor General attended as the acting Attorney General.

Cabinet:

1. Approved the Virgin Islands National Tourism Policy 2026–2036 as Government’s overarching policy framework for the sustainable growth, diversification and management of the tourism sector; decided
 - a. that the Ministry of Tourism, Culture and Sustainable Development consult with the relevant ministries and agencies and thereafter provide drafting instructions to the Attorney General’s Chambers for the formulation of a Tourism Development Act, consistent with and informed by the National Tourism Policy 2026–2036; and
 - b. that the Virgin Islands National Tourism Policy 2026–2036 be laid on the table in the House of Assembly at the next convenient sitting.
2. Decided:
 - a. that Mr. William Richard Hare be appointed as Pro Tem Chairperson of the Labour Arbitration Tribunal effective 1st July 2026, for a period of four (4) months, to oversee the arbitration proceedings in disputes, in accordance with Section 29 of the Labour Code, 2010;
 - b. that the Ministry of Financial Services, Economic Development and Digital Transformation instruct the Attorney General’s Chambers to prepare the instrument of appointment for Mr. William Richard Hare as Pro Tem Chairperson of the Labour Arbitration Tribunal effective 1st July, 2026 for a period of four (4) months; and noted

- c. that remuneration in the amount of two thousand, five hundred dollars (\$2,500.00) per month will be paid to the Pro Tem Chairperson.
- 3. Reviewed and accepted the recommendations of the Board of Immigration:
 - a. to grant Certificates of Belonger Status to twenty-two (22) persons who, in accordance with section 16(6) of the Immigration and Passport Act (revised) are the spouses of Belongers, and who have been living together with their spouses within the Territory for a period not less than five (5) years;
 - b. to not grant one Certificate of Belonger Status on the basis of marriage, in accordance with section 16(6) of the Immigration and Passport Act;
 - c. to grant Certificates of Belonger Status to eighty (80) applicants, who, in the opinion of the Board, have met the legal requirements of Section 16(3) of the Immigration and Passport Act; and
 - d. directed that the Ministry of Financial Services, Economic Development and Digital Transformation instructs the Department of Immigration to communicate Cabinet's decision to the respective applicants in a timely manner.
- 4. Reviewed and approved the twenty-four (24) applications for 4th Generation Belonger Status, in accordance with the Immigration and Passport Act Section 5A, where provision is made for persons who is a great-grandchild of a person who belongs to the Virgin Islands by virtue of section 2(2)(d) of the Virgin Islands Constitution; and directed that the Ministry of Financial Services, Economic Development and Digital Transformation instruct the Department of Immigration to communicate Cabinet's decision to the respective applicants in a timely manner.
- 5. Noted the additional information provided in response to its request regarding the implementation and performance of the Public Assistance Programme following the grant increases approved in February 2025.
- 6. Noted:
 - a. the Enhanced Country Poverty Assessment (eCPA) is a regional poverty and vulnerability assessment approach that uses multiple analytical tools to examine living conditions, multidimensional poverty, institutional capacity, gendered poverty, and the wider socio-economic context;
 - b. the British Virgin Islands' eCPA findings provide an evidence base for continued policy development, planning, and service delivery across all ministerial areas of Government; and

- c. the Ministry of Health and Social Development intends to circulate the eCPA analytical outputs to relevant ministries and contributing stakeholders for their information and consideration in sector planning.
7. Reviewed and approved the International Non-Governmental Organisations Regulation Bill, 2026, which seeks to establish a clear legal framework for the registration, monitoring, and reporting of INGOs, ensuring transparency, accountability, and alignment with national development priorities; and agreed that the Bill be introduced for its first reading at the next convenient sitting of the House of Assembly.

Cabinet Meeting – 24th June, 2026

His Excellency the Governor Daniel Pruce chaired the meeting held on 24th June, 2026.

All Members were present, with the exception of the Minister for Education, Youth Affairs and Sports, who was absent on official duty.

Cabinet:

1. Noted the 2025 Annual Report of Virgin Islands Public Service Learning Institute; and agreed that it be laid on the table at the next convenient sitting of the House of Assembly in accordance with section 26 of the Public Service Management Act.
2. Approved:
 - a. the appointment of Ms. Marion Blyden to serve as a member of the Public Assistance Committee in accordance with Section 3(2)(b) of the Public Assistance Act, 2013 for a period of two (2) years with effect from 1st May 2026 until 30th April, 2028;
 - b. the reappointment of Ms. Margaret Jones Greene to serve as a member of the Public Assistance Committee in accordance with Section 3(2)(b) and Section 8(1) of the Public Assistance Act, 2013 for a period of three (3) years with effect from 1st May 2026 until 30th April, 2029; and noted
 - c. that the chairperson receives stipendiary compensation of one hundred and fifty dollars (\$150), while other members receive stipendiary compensation at the rate of \$125.00 per meeting attended.

3. Approved:

- a. the appointment of Mr. Marvin Grant as Chairman to the Non-Profit Organisation Registration Board in accordance with section 3(3) of the Non-Profit Organisations Act, 2012 with effect from 15th May, 2026 until 23rd August, 2026;
- b. the appointment of Ms. Karla Dawson as Member and Deputy Chairman to the Non-Profit Organisation Registration Board in accordance with section 3(2)(a) and 3(3) of the Non-Profit Organisations Act, 2012 for a period of two (2) years with effect from 15th May, 2026 until 14th May, 2028;
- c. the appointment of Mrs. Monel Nickie to the Non-Profit Organisation Registration Board in accordance with section 3(2)(a) of the Non-Profit Organisations Act, 2012 for a period of two (2) years with effect from 15th May, 2026 until 14th May, 2028;
- d. the appointment of Mr. Ryan Geluk as the representative from the Joint Anti-Money Laundering and Terrorist Financing Advisory Committee (JALTFAC) to the Non-Profit Organisations Registration Board in accordance with section 3(2)(c) of the Non-Profit Organisations Act, 2012 for a period of three (3) years with effect from 15th May, 2026 until 14th May, 2029; noted
- e. that, in accordance with Section 3(2)(b) of the Non-Profit Organisations Act, 2012, as amended, the Permanent Secretary or Deputy Secretary of the Ministry of Health and Social Development responsible for voluntary organisations shall serve as an *ex officio member* of the Non-Profit Organisation Registration Board by virtue of office; and
- f. that the Chairman is remunerated at the rate of four hundred dollars (\$400) per quarter, while the Deputy Chairman and members are remunerated at the rates of three hundred dollars (\$300) and two hundred and fifty dollars (\$250) respectively, subject to regular attendance at meetings.

4. Noted:

- a. in accordance with the 2000 Memorandum of Understanding Re: Legal Aid between the Government of the Virgin Islands and the BVI BAR Association, the following persons have been appointed to the Legal Aid Board for a period of two (2) years, effective 20th May 2026 to 19th May 2028:
 - i. Ms. Ingrid A. Moses-Scatliffe, representing a member of the public in good standing with the community;

- ii. Ms. Susan V. Demers, representing the first Private Sector Attorney and Bar Association Appointee;
 - iii. Mr. Timothy de Swardt, representing the second Private Sector Attorney and Bar Association Appointee;
 - iv. the Registrar of the High Court as an *ex officio* member; and
 - v. the Chief Social Development Officer as *ex-officio* member
- b. that no financial remuneration is provided to members of the Legal Aid Board.
